Introduction

All Isle of Wight providers will use their best endeavours and adopt a similar approach to meeting the needs of pupils with Special Educational Needs. Schools are supported by the Local Authority to ensure that all pupils, regardless of their specific needs, make the best possible progress in school. All schools are supported to be as proactive and inclusive as possible, with the needs of pupils with a Special Educational Need/s being met in a mainstream setting wherever possible, where families want this to happen.

Admissions

Children and young people, with SEND are allocated places in two separate & distinct ways:

Those children and young people with Education Health and Care Plans have a separate admissions procedure overseen by the IW SEND Assessment and Review team.

Those children and young people who have SEND but do not have an Education, Health and Care Plan are admitted via the normal school admissions criteria.

- Staff who visit from outside agencies such as Speech and Language therapy (SALT) Service from private agencies or the NHS

Primary Behaviour Service, CAMHS [Child and Adult Mental Health Services], Barnados family support services and working with our part time ELSAs [Emotional Literacy Support Assistants] who are also TAs in class
4. How can I let the school know I am concerned about the progress of my child/young person in school?	<ul style="list-style-type: none"> In the first instance please contact your child's class teacher to discuss any worries You can request further meetings with the SENCO or Head Teacher if necessary Should a complaint be necessary, there is a Complaint Procedure to follow. Please contact the school office. Termly parents evenings are offered to parents
5. How will the school let me know if they have any concerns about my child/young person?	<ul style="list-style-type: none"> The Class Teachers are constantly reviewing and assessing your child's progress. There are Parent and Teacher Consultations in October and February/ March and progress reports sent out in the Spring Term for all children. You will be contacted as soon as necessary if there are any concerns. A meeting will usually be arranged to discuss your child's needs. The SENCO may request to attend or as parents you may request for the SENCO to be present.
6. How is extra support allocated to children and young people and how do they move between the different levels?	<ul style="list-style-type: none"> Extra support is identified in termly progress meetings with the Class Teacher, SENCO and Headteacher. They will identify which groups of pupils or individual children need what type of extra support, and then staff will be allocated accordingly. Any child needing extra support through intervention will be carefully monitored in terms of their level of progress to ensure they exceed expected level of progress in order for them to move their learning forward.

How are staff in the school supported to work with children & young people with SEND?</p> <p>a) What training have the staff supporting children/young people with SEND had or have available?</p>	<ul style="list-style-type: none"> ● St Helens Primary School employs a SENCO for one day a week. ● All our staff, both Teachers and Learning Support Assistants, are given training and support. Some training is done at school by Subject Team Leaders, SENCO or the Head Teacher. ● Staff are given the opportunity to attend Local Authority Professional Development Training which the school buys into. ● Two members of staff are trained in ELKLAN (speech and language) ● The school buys in to specialist Outreach Services and has access to training across a range of needs including ASC <p>Mrs. Linnell [SENCO] achieved the National SENCO Qualification in 2016. SEND has a regular place on staff meeting agendas enabling sharing of good practice between staff</p> <p>Specific LSAs have training in Speech and Language and other support staff have received training in specific interventions.</p>	

<p>9. How will activities/teaching be adapted for my child/young person with learning needs?</p> <p>a) How will the curriculum be matched to my child's/young person's needs?</p> <p>b) How will both you and I know how my child/young person is doing and how will you help me to support my child/young person's learning?</p>	<ul style="list-style-type: none"> • Teaching will be varied by the Class Teacher depending on the needs of your child. If specialist equipment is required then it will be provided by the school unless parents wish to provide their own equipment for use. • Learning Support Assistants are timetabled to work with children in groups or individuals where necessary. • The curriculum will be fully inclusive and matched to suit the needs of your child so that he/she can access everything. Lessons are adapted and support given and visuals provided where necessary. • Teachers are expected to deliver lessons that are engaging and have a variety of approaches. • The Class Teacher and SENCO keep records to monitor your child's progress. • There is a specific computer programme that all staff use to input their assessments. All staff can access this to monitor progress for their subject responsibility. • Meetings are available to discuss your child's needs and progress. Your child is encouraged to have an active part in any discussion about their needs and learning. • The School can advise you on how best you can support your child's learning at home. • We can provide you with details of SENDIASS, an external independent service who can support you at meetings, with paperwork and provide advice (01983 825548 email sendiass@iow.gov.uk) • We can signpost you to services, websites and voluntary organisations that can provide you with additional information, support and advice. • We will apply for access arrangements, if necessary and appropriate, for testing situations (e.g. Key Stage 2 SATs) • We work with outside agencies to support the delivery of the curriculum for children with SEND and implement their advice in the classroom. • We will talk to children about their learning plan when this is appropriate and provide it in a format that is best suited to them, with supporting visuals if necessary.

How will the school measure the progress of my child/young person?</p>	<ul style="list-style-type: none"> • Pupil Progress meetings are held termly and the progress of all children will be looked at using the school tracker system and SEN Provision maps. • Targets are given to all children and then progress is measured against these. <p>Adequate progress is defined as that which narrows the attainment gap between pupils and peers by:</p> <ul style="list-style-type: none"> • Preventing the gap increasing • Equals or improves pupils previous progress rate

<p>11. What is the pastoral, medical and social support available in school?</p> <p>a) What support will there be for my child/young person's overall well being?</p> <p>b) What support is there for behaviour to avoid exclusions and increase attendance?</p>	<ul style="list-style-type: none"> • At St. Helens Primary school we spend time ensuring children are happy and ready to learn. Teachers get to know the children well. • The School Nurse can arrange a meeting to discuss any medical or health needs that your child may have • Social Skills groups • The Relationships and Health Education Curriculum is taught to all children • Most staff in school are first aid trained • Medical needs are recorded and children with significant needs e.g. allergies requiring an epipen, are known to all staff • Two ELSA trained staff can offer social and emotional support for groups of children, or, occasionally, on a 1:1 basis on a part-time basis as they are also Classroom Learning Support Assistants. • We can refer to local counselling services e.g. KissyPuppy. • We monitor attendance closely and will support you to ensure your child's attendance is 95% or above.
<p>12. What support does the school have for me as a parent of a child/young person with a SEND?</p>	<ul style="list-style-type: none"> • We have an open door policy where you can come and chat to Class Teachers, SENCO and Head Teacher when you need to at a mutually agreed time. Each member of staff has an email address that parents can also make contact through. • We offer Early Help to families that meet the criteria. Through these further support can be accessed. Mr. Wake is the Lead for the Early Help.
<p>13. How does the school manage the administration of medicines?</p>	<ul style="list-style-type: none"> • Please see the Schools Policy on administering medicines • Some staff are trained with the safe handling of oxygen • Most staff are first aid trained • Most staff are trained in using a defibrillator • Many staff are trained in supporting children with Diabetes Type I

<p>14. How accessible is the school environment? (including after school clubs and school trips)</p>	<ul style="list-style-type: none"> • We are a fully inclusive school. • The school office is manned between 8am and 4pm with an answerphone outside these hours. • The main building is accessible to those with physical disabilities as is the Year1/2 classroom. There are two shallow steps in the EYFS classroom. Portable ramps would be made available if necessary. The playground would need to be accessed through the front entrance and the carpark. • The mobile classroom is not easily accessible to those with physical disabilities due to the small space available, but a ramp is provided to access the cloakroom and into the classrooms and a larger toilet space is available to accommodate a wheelchair. The doors are not easy open/close doors. The mobile classroom is accessible via the outside of the building through the carpark. To reach the hall the same route would need to be taken with entry through the main school door. • We have a wet room available in the main school building with an accessible toilet with rails. • School trips are accessible for children with SEND and we work in partnership with parents for their support. • After school provision is accessible for children with SEND and we work in partnership with parents for their support. • Resources are accessible for children with SEND and are sometimes adapted to suit the needs of children with SEND. • We are seeking advice from the Local Authority for improving accessibility for pupils with a physical disability.
<p>15. How will the school support my child/young person when they are leaving? OR moving to another Year?</p>	<p>At St Helens we know transitions are very important.</p> <ul style="list-style-type: none"> • We have very close links with the Pre-School. The Reception Teacher will run play /story times for the Pre-School children to visit with Pre-School staff. This runs over the months running up to the Summer Holidays. The SENCO will visit the Pre-School on site in the summer term to meet the children moving up. • If a child is attending another Pre-School, visits will be made by the class teacher and the SENCO if the child has an EHCP. • We have close links with our Secondary schools and will have meetings with them to ensure that your child has a smooth transition to Year 7. • When a child has a special educational need we complete transition booklets with them to ensure they are adequately prepared to move to the next class. This booklet will contain photographs of the children's new teacher and pictures of their new classroom. The children can then take these home so they can chat to you about what is happening to them. • New teachers meet with the previous teacher to discuss children moving up.

	<ul style="list-style-type: none"> • Additional visits to the classroom will be arranged and to meet key staff for children who need it. • When children move to another setting within year, we will ensure your child's needs are discussed with the receiving school. • We will contact a previous school to talk to key staff about a new child arriving at St Helens Primary School. • Transition Partnership Agreements can be drawn up with your child's previous or new setting when deemed necessary. • Reception Class teachers will make home visits before a child joins the Reception Class in September to meet with parents and see the child in their home environment.
What additional support is available to my Looked After Child who has SEN as well?	<ul style="list-style-type: none"> • The designated Teacher at St Helens Primary School is Mr Carl Wake. • As a school we meet with Social Workers and any other professionals as necessary and prepare together a Personalised Education Plan which will complement the Pupil Passport to provide additional support for the child to help them succeed. This is monitored termly and adjusted according to the impact of the provision and what needs to happen next. • Meetings with an Educational Psychologist will be made through the Local Authority if necessary to help support and advise us on the best way to support the child. • The child will have priority to meet with the ELSA in school, if necessary, to discuss any social, emotional and mental health needs they may have and work on a programme of support. • The designated teacher will attend meetings and training regularly to ensure the correct procedures are taking place in school.

<p>What are the arrangements for handling complaints from parents of children with SEND about the provision made at school?</p>	<p>It is in everyone's interests for complaints to be resolved as quickly and effectively as possible. Our SEND complaint procedure is as follows:</p> <ul style="list-style-type: none"> • Initially the complaint is dealt with by the class teacher. Class teachers will listen to all the points raised and seek ways to address the issues. • If the matter remains unresolved, the complaint will be dealt with by the SENCO in consultation with the Headteacher. • If there is still no resolution the Headteacher will become actively involved. • If the matter is still not resolved, the complainant must put their complaint in writing to the Chair of Governors and the Governing body will deal with the matter through their agreed complaint resolution procedures. • The school's complaints policy is available on the school website.
